

THOMAS J. MARQUEZ'S NOTES

- Page 16 The clause referred to in the middle of the page is not normally in EDS contracts.
- Page 30 In 1969 Henry Kissinger was Chief Foreign Policy Advisor in the White House. He was not Secretary of State. Henry Kissinger was Secretary of State from September 22, 1973 - January 20, 1977.
- Page 31 Bill Sullivan was not the Ambassador to Laos during our POW effort. He was a former Ambassador to Laos, having been appointed in 1964. In 1969 he was Deputy Assistant Secretary of State for Asian and Pacific Affairs.
- Page 33 It might be interesting to mention that Clint Eastwood was also at the party for the Son Tay Raiders.
- Page 40 Description of TJ inaccurate, but don't change a word.
- Page 41 &
51 Ambassador Zahadi had returned to Iran and was there when Moore and Kissinger both talked to him. He was running the country because the Shah had gone into a very depressed state.
